Mason is excited to welcome you in person or virtually this fall! This email contains **updated information** so please read to the end. For those of you planning to be on campus, we know you are busy preparing for your intended travel to the United States and would like to share some important information about the University's plans for a safe re-opening this August.

**Please complete [our Survey](#) by August 1:**

- Have your Mason NetID and password ready
  - To get a Mason NetID and password, you need to set up your Patriot Pass first. To sign up for Patriot Pass, change your password, or get a new password, go to [strongpassword.gmu.edu](http://strongpassword.gmu.edu). Note that your Claim Code/PIN is your 6-digit date of birth in the format mmddyy (month month day day year year)
- Access the survey by clicking this link and logging in.

If you are not sure how to answer some of the questions at this time, we still ask that you complete the survey with the most accurate information you can provide.

**What is the COVID vaccine requirement for Mason?**

- **The DEADLINE to be fully vaccinated is August 1, 2021.**
  - Some vaccines require two doses and a waiting period to be considered fully vaccinated. Please plan accordingly.
- Your vaccine must appear on the World Health Organization (WHO) Emergency Use List (EUL) COVID-19 vaccine.
- You are required to be vaccinated if:
  - You live on campus in a residence hall
  - You are registered for at least one in-person or hybrid class for the fall semester; or
  - You plan on attending any on-campus events.
- You can get an exemption (special exception from the requirement) from the vaccine for [medical](#) reasons and [religious](#) beliefs:
  - Review and approval are required.

  - Any student granted an exemption will be required to mask and practice physical distancing while on campus.

### How do I meet the requirement?

- Upload proof that you have been vaccinated via the [Student Health Services COVID Vaccine Information page](#) and the [Student Health Portal](#).
- Check your immunization requirement status by checking the [Student Health Services portal](#). Please allow 5-7 business days as we are experiencing high volume.

### What if I can't meet the requirements?

If you are an international student and unable to fully vaccinate in your home country or current location by the August 1 deadline, you could still be able to come to Mason.

- Email the Immunization Office at [immunize@gmu.edu](mailto:immunize@gmu.edu) to request an extension as soon as possible before the August 1 deadline.
- We can give you more time to complete your vaccination after you arrive.
- Mason will host COVID-19 vaccination clinics at the beginning of the semester.
- Local pharmacies offer the vaccine. All COVID-19 vaccines in the US are given free of charge.

### Will I need to quarantine?

Students who are not fully vaccinated and are coming to Mason from outside the US will be required to quarantine for 7-10 days, as recommended by the US Centers for Disease Control and Prevention (CDC) guidelines.

- Students living on campus and arriving on August 16 or later will be provided space to quarantine on campus in a designated residence hall. If you arrive before your housing contract begins on either August 18 (first year) or August 20 (upper class), you will be charged \$55/night until the start date.
- While meal deliveries will not be provided, students will be permitted to order grab & go meals from campus dining locations.
- Students living off-campus, including those living alone, living with roommates, or living with relatives, will be expected to quarantine in their off-campus residence.
- Students can finish quarantine in 7 days, provided they have a negative COVID test 3-5 days after arrival in the US. Mason will make testing available to students who need it.

### Other Immunization Requirements

In addition to COVID requirements, Mason also requires other vaccines and TB screening of all incoming students. Please click on the [Student Health Immunizations page](#) for further information. Be sure to read the entire page.
