Responsibilities of J-1 Students

Students in J-1 status are responsible for learning, understanding, and complying with U.S. federal laws and regulations governing J visa status. Responsibilities include, but may not be limited to, the following:

Report Address, Telephone or E-mail Address Changes to the Office of International Programs and Services (OIPS): This may be done by email oips@gmu.edu or cbodziak@gmu.edu or ichizhov@gmu.edu

Depart the United States within the 30 Day Grace Period: Students must depart the United States within 30 days of the expiration of the Form DS-2019 or program end date, whichever is earlier.

Report Departure Date and Reason to OIPS: J-1 students are required to inform their J-1 Advisor if they plan to leave the University before the expiration date on their Form DS-2019/Certificate of Eligibility for Exchange Visitor Status.

Participate Fully in the Academic Program: All J-1 Students must fully participate in the George Mason University academic program for which they have been approved.

Maintain Required Health Insurance: Minimum coverage shall provide:

1. medical benefits of at least \$100,000 per accident or illness
2. repatriation of remains in the amount of \$25,000;
3. expenses associated with medical evacuation of the exchange visitor to his or her home country in the amount of \$50,000; and
4. a deductible not to exceed \$500 per accident or illness.

Adhere to all GMU policies, local, Virginia State and Federal Law.
